Campground rules Zeltplatz Oberhart

(gültig ab 28.09.2023)

- 1. The surrounding forest and the adjacent meadow do not belong to the campsite. Please do not go into the forest during dawn and dusk (our game should be able to graze in peace).
- 2. The youth protection law is valid on the whole area. Its observance is binding for all.
- 3. Quietness from 24:00 o'clock to 07:00 o'clock; from 22:00 o'clock reduced volume. When operating sound carriers, radios, etc., the volume of the tent is to be respected.
- 4. Campfires are only allowed at the designated campfire site.
- 5. In case of forest fire warning level 4 or 5 and strong wind/storm no campfires are to be lit. The visitor himself is obliged to inform himself about the current forest fire warning level.
- 6. Campfires or other open fires must not be left unattended at any time.
- 7. Please use the sanitary facilities (no wild booze!!!), as there are highly endangered yellow brook toads living in the nearby area.
- 8. Motor vehicles may only be parked in the designated parking spaces. Driving on the meadow with cars or trailers is strictly forbidden. In case of disregard we have to charge according to the damages.
- 9. Use of electrical equipment (sockets) is at your own risk.
- 10. Waste of all kinds is to be disposed of in the containers provided. Please separate your garbage and avoid unnecessary packaging!
- 11. Garbage has to be disposed at the local recycling center when leaving the campground or has to be taken away.
- 12. It is forbidden to dispose of cooked food and animal products (including eggshells) on the compost. In case of violation we charge a fee of 100€.
- 13. The instructions of the groundsman must be followed.
- 14. Measures that change the ground are not allowed or must be agreed upon with the ground keeper beforehand (e.g. earth refrigerator, water ditches, etc.).
- 15. In case of gross violations of the rules of the site, the group can be expelled from the site with immediate effect.
- 16. Construction wood is provided free of charge, but must not be damaged (sawing, chopping, carving, drilling, screwing, etc.)
- 17. The visitors are obliged to clean the sanitary facilities and the accommodation building independently according to the number of participants and the degree of pollution during the occupancy.
- 18. The cleaning has to be done exclusively with the provided cleaning materials. Failure to do so may cause damage to the biological treatment plant.
- 19. The hygiene instructions must be observed at all times.
- 20. The caretaker must be informed immediately of any damage.
- 21. In case of heavy soiling at the end of the occupancy an additional cleaning fee of 100€ will be charged.

These campground rules are a translation of the German version. In the event of disputes or litigations the German version shall apply at all times.
